

**NOTICE TO BIDDERS
NOTICE OF PUBLIC HEARING ON PROPOSED PLANS AND SPECIFICATIONS
PROPOSED FORM OF CONTRACT AND ESTIMATE OF COSTS
FOR THE CONSTRUCTION OF CERTAIN WATER SYSTEM IMPROVEMENTS
IN THE CITY OF DELOIT, IOWA
AND THE TAKING OF BIDS FOR SUCH IMPROVEMENTS**

Sealed proposals will be **received** and opened at the Deloit Community Building at 320 Maple Street at **10:30 A.M.** on the **8th** day of **February, 2007**, for the construction of certain water system improvements and such other work as may be incidental thereto, as described in the plans and specifications therefor now on file in the office of the City Clerk entitled:

**2007 WATER SYSTEM IMPROVEMENTS
DELOIT, IOWA**

Any bids hand delivered prior to the bid opening time must be delivered to the Mayor's place of business "Hair Depot" at 102 Wolf Street in Deloit. Any bids mailed can be mailed to the City of Deloit, P.O. Box 473. Deloit, Iowa 51441. Any bids hand delivered or mailed prior to the bid opening time must be received at the places specified above by no later than the 7th day of February, 2007.

At said time and place, proposals received will be opened and the results will be announced. Proposals will be acted upon by the City Council at their regularly scheduled meeting at 7:00 P.M. on February 13, 2007.

A hearing will be held by the City Council on the proposed plans and specifications, proposed form of contract and estimate of cost for said improvements at a meeting to be held in the Council Chambers at City Hall at **7:05 P.M.** on **January 9, 2007**, and at said hearing, any interested person may appear and file objections thereto.

The improvements consist of the following approximate quantities:

DIVISION 1- WATER STORAGE

1 LS 17 ft. Dia. X 95 ft. Stand Pipe, including Foundation; 1 LS Demolish Old Tank; 1 LS Level Control; 60 LF Watermain, PVC, 6 In. Dia.; 6 In. Fittings; 1 EA Gate Valve and Valve Box, 6 In.; 1 LS Generator; 0.2 AC Seeding, Fertilizing and Mulching; Mobilization and other items incidental thereto.

DIVISION 2 – WATER MAINS & METERS

135 SY Removal of Pavement; 45 TON Hot Mix Asphalt Mixture; 5 TON Surfacing, Class A, Crushed Stone; 1,330 LF Watermain, PVC, 6 In. Dia.; 6 In. Fittings; 4 In. Fittings, 1 EA Gate Valve and Valve Box, 6 In.; 1 EA Gate Valve and Valve Box, 4 In.; 4 EA Connect to

Exist Main; 90 LF Water Service Line, Copper, ¾ In. Dia.; 2 EA Corporation Stop with Service Saddle, ¾ In. Dia.; 2 EA Reconnect Service; 2 EA Cut and Plug Exist Main; 120 EA Furnish and Install TouchRead Water Meter; 0.4 AC Seeding, Fertilizing and Mulching; Mobilization and other items incidental thereto.

Bidders may bid on either or both sections. A separate contract will be awarded for each section, and no tied bids will be permitted.

Each proposal shall be made on a form furnished by the City and must be accompanied by a cashier's or certified check drawn on a bank in Iowa or a bank chartered under the laws of the United States or a certified share draft on a credit union in Iowa or chartered under the laws of the United States or a bid bond executed by a corporation authorized to contract as a surety in Iowa and filed in an envelope separate from the one containing the proposal, sealed and in an amount equal to **TEN PERCENT (10%)** of the amount of the proposal, made payable to the City Treasurer of the City of Deloit, Iowa, and may be cashed by the City as liquidated damages in the event the successful bidder fails to enter into a contract within 10 days of award and post bond satisfactory to the City insuring the faithful fulfillment of the contract as required by law and the specifications.

Payment to the contractor will be made in cash from funds on hand which may be legally used for such purposes including but not limited to all proceeds of governmental grants or loans as may be obtained. Payment will be made monthly by the City of Deloit based on estimates of ninety-five percent (95%) of the contract value of the work completed in an acceptable manner. The monthly progress payment will be made within thirty (30) days from the date the progress payment is approved by the City Council. Five percent (5%) of each project estimate will be retained and held as a suspended payment. Final payment will be made not less than thirty (30) days after completion of the work and acceptance by the City Council. Retention of unpaid funds and final payment shall be in accordance with Chapter 573, Code of Iowa, as amended.

The successful bidder will be required to furnish a bond in an amount equal to one hundred percent (100%) of the contract price, said bond to be issued by a responsible surety approved by the City and shall guarantee the faithful performance of the contract and terms and conditions therein contained, shall guarantee the prompt payment for all materials and labor and protect and save harmless the City from claims and damages of any kind caused by the operations of the Contractor, and shall also guarantee the maintenance of all work and materials in good repair for not less than four (4) years from the time of acceptance of the improvements by the Owner.

Plans and specifications governing the construction of the proposed improvements have been prepared by Sundquist Engineering, P.C., Consulting Engineers for the City, which plans and specifications and the proceedings referring to and defining said proposed improvements are hereby made a part of this Notice and the proposed contract by reference, and the proposed contract shall be executed in compliance therewith. Copies of said plans and specifications are now on file in the City Clerk's office at City Hall, for

examination by bidders. Copies of said plans and specifications may be obtained from the Engineer at his office at 120 South Main, P.O. Box 220, Denison, Iowa, upon request and deposit of \$40.00, non-refundable.

The work on Division 1 of the proposed contract shall be commenced within 10 calendar days after written Notice to Proceed is issued, and shall be completed within 100 working days but no later than July 17, 2007. The late start date is February 26, 2007.

The work on Division 2 of the proposed contract shall be commenced within 10 calendar days after written Notice to Proceed is issued, and shall be completed within 60 working days but no later than May 31, 2007. The late start date is March 7, 2007.

Liquidated damages in the amount of \$400 per day shall be assessed the contractor for each calendar day that work proceeds on the project beyond the specified completion date, excepting authorized extensions thereof.

By virtue of statutory authority, a preference will be given to products and provisions grown and coal produced within the State of Iowa, to materials supplied by companies from within the State of Iowa and to Iowa domestic labor.

The City hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of sex, race, color or national origin in consideration for an award.

The City reserves the right to reject any or all proposals and to waive informalities.
